50 CFR 100.4 Definitions

Resident means any person who has his or her primary, permanent home for the previous 12 months within Alaska and whenever absent from this primary, permanent home, has the intention of returning to it. Factors demonstrating the location of a person's primary, permanent home may include, but are not limited to: the address listed on an Alaska Permanent Fund Application; an Alaska license to drive, hunt, fish, or engage in an activity regulated by a government entity; affidavit of person or persons who know the individual; voter registration; location of residences owned, rented or leased; location of stored household goods; residence of spouse, minor children or dependents; tax documents; or whether the person claims residence in another location for any purpose.

_____ I certify that I am a rural resident as defined in 50 CFR 100.4; and that the Federal Subsistence Hunting/Fishing Permit I am requesting are to be used solely for subsistence uses as defined in Title VIII of the Alaska National Interest Lands Conservation Act (ANILCA), and the Federal Subsistence Management Regulations (50 CFR 100).

_____ I understand that eligibility to hunt and fish on these lands and waters under federal subsistence regulations is based on the location of my **primary, permanent residence**, not the location of my post office box, and that a seasonal residence does not qualify, and that my primary place of residence must be located in the "Species/Customary & Traditional Use Determination" column of the regulation book for the species and location where I plan to hunt.

_____ I understand that if I am convicted of making false statements or fraudulent application to obtain Federal Subsistence Hunting/Fishing Permits, I may be fined under 18 USC 1001 or imprisoned not more than 5 years or both; and under 50 CFR 100.6 (f) I may be punished by a fine of up to \$100,000.00 or by imprisonment of up to 1 year or both.
